(Head Office: Chuo-ku, Tokyo; Representative Director and President: Yutaka Nagao) announces that it has been selected as an Environment Sustainable Company in the Environment Sustainable Category of the 5th ESG Finance Awards Japan organized by the Ministry of the Environment.



The Yamato Group is proactive in working to practice sustainable management to bring about a sustainable society. In February 2024, we announced the Yamato Group Medium-Term Management Plan "Sustainability Transformation 2030 ~1st Stage~," which aims to achieve a sustainability transformation that enhances both social and corporate sustainability in order to achieve greater prosperity with fewer resources.
