

Released Kuroneko Billing and Reconciliation DX, Digitalizing Processes from Invoicing to Payment Reconciliation to Help Businesses Improve Operational Efficiency

Yamato Credit & Finance Co., Ltd. (Head Office: Toshima-ku, Tokyo; Representative Director and President: Yuji Motoyama), a subsidiary of Yamato Holdings Co., Ltd. (Head Office: Chuo-ku, Tokyo; Representative Director and President: Yutaka Nagao), hereby announces that it has launched the Kuroneko Billing and Reconciliation DX service on November 4, 2025, supporting business-to-business accounts receivable transactions.



■ Overview and Features of Kuroneko Billing and Reconciliation DX

While many companies are now working to digitalize their business processes, many analog processes remain, such as issuing paper invoices, enclosing and sealing invoices, and reconciling payments in business-to-business accounts receivable transactions. Kuroneko

Billing and Reconciliation DX streamlines business processes through digitalization of everything from invoice issuance to payment reconciliation.

Invoice issuance

- 1. Simply upload your billing data to the business portal provided by Yamato Credit & Finance, and you can issue electronic invoices compliant with Japan's qualified invoice system.
- 2. You can choose to send invoices either via the web (electronic) or by mail (paper), selecting the appropriate method for each business partner.
- 3. Issued invoices are retained for up to 12 years, thus complying with the retention requirements of Japan's act on electronic bookkeeping. Business partners who receive electronic invoices can also register as members of Yamato Credit & Finance's business portal to store and search invoices received for 12 years.

Payment reconciliation

- 1. By opening an account with Yamato Credit & Finance's NEOBANK^{*1 *2} banking service for customers using Yamato Credit & Finance's Business Portal, and by designating a dedicated bank transfer account issued for each client as the payee, the billing data from the invoice issued by Kuroneko Billing and Reconciliation DX can be matched with the data from the dedicated bank transfer account and automatically reconciled.
- 2. By setting reconciliation conditions based on the invoice amount and payment due date for each business partner, the system automatically matches (reconciles) the invoices.

A signup campaign will be held for a limited time to waive the initial and optional monthly fees for Kuroneko Billing and Reconciliation DX.

- Period: November 4, 2025 to May 31, 2026
- Eligibility: Businesses that newly apply for Kuroneko Billing and Reconciliation DX during the campaign period

- (1) Standard service fee: Waived initial fee of 10,000 yen (excluding tax)
- (2) Invoice mailing optional fee: Waived initial fee of 10,000 yen (excluding tax); monthly fee of 5,000 yen (excluding tax) waived every month during the campaign period
